### **STANDING ORDERS**

### In order that the proceedings of the Congress be carried out expeditiously, the following Standing Orders will be observed:

- 1. The proposer of a Resolution or an Amendment thereto may speak for 5 minutes, but not more than 5 minutes
- 2. A delegate speaking to a Resolution or an Amendment must not exceed 3 minutes. A maximum of two delegates from any one county shall speak on any one motion.
- 3. The proposer of a Resolution or Amendment may speak a second time for 3minutes before a vote is taken, but no other Delegate may speak a second time to the same Resolution or Amendment.
- 4. The Chairman may at any time he considers a matter has been sufficiently discussed call on the Proposer for a reply, and when that has been given a vote must be taken.
- 5. A delegate may, with the consent of the Chairman, move "that the question be now put", afterwhich, when the Proposer has spoken, a vote must be taken.
- 6. A speaker to National Manager's report or to any other general discussion shall not exceed 3 minutes on any one topic.
- 7. Any motion seeking to amend a rule in Fo-Rialacha (GAA Handball Ireland) must have a majority equal to two-thirds of those present entitled to vote and voting.
- 8. Standing Orders shall not be suspended for the purpose of considering any matter not on the agenda, except by the consent of a majority equal to two-thirds of those present entitled to vote and voting.
- 9. The Chairman may change the order of items on the agenda with the support of a simple majority of those present entitled to vote and voting.

# YEAR IN REVIEW



Similar to the previous year, GAA Handball were only able to proceed with a limited number of competitive events in 2021. It was majorly disappointing not to be in a position to run any 2021 editions of the All-Ireland Championship, however all outstanding 2020 Finals were played to a completion.

### HISTORIC 1ST ONLINE GAA HANDBALL AGM

### STRATEGIC PLAN LAUNCHED

### In August, GAA Handball launched a five-year strategic plan to lead the association until 2025.

The strategic plan is the culmination of many months of work by the Strategic Planning workgroup and will guide the Association over the next five years. Following a difficult 18 months for the Sport due to Covid-19 restrictions the plan is a welcome positive milestone and represents a path forward for the Association to reach it's goals and grow the sport once more following the effects of the pandemic.

President Dessie Keegan spoke of his delight at seeing the Strategic Plan launched following an extensive period of consultation.

"I am delighted to launch our excit-

ing new Strategic Plan. The plan is the culmination of months of work and research and sets out an exciting path for our association. The core ambition of this Strategic Plan is straightforward - to increase participation and retention of players and volunteers. This Strategic Plan is being launched against the backdrop of one of the most extraordinary global events ever seen in human history, Covid-19. It is important to acknowledge the impact of this, however its more important to adapt to this situation and to overcome the challenge. This will require each of us to be open minded and willing to try new ideas."

Headline targets in the plan include:

- Development of a network of fully supported officials, coaches and administrators to effectively support all levels of the Association
- Increased media coverage of key GAA Handball events in local and mainstream media
- Development of Handball as a recreational sport.
- Development of a balanced Clár catering for all members and officials.
- Increase staffing levels to support the growth of the game.
- Continue the great work being done to grow and promote Women in Sport.
- Increase financial investment from internal, commercial, public funding and sponsorship opportunities

National Manager John Kelly welcomed the plan and stressed the importance of all units buying into the plan to ensure it is a success.

"I am delighted to welcome this exciting new strategic plan for GAA Handball that will guide us as an association through the next number of years. Following what has been an extremely tough year for all involved in the sport due to Covid-19 it is vital that we have a plan such as this to help restrengthen our sport and maximise our potential in the years ahead. It is vital that all our units embrace this plan and work together and in the end the result will justify the effort with a stronger association for everyone."





### DELAYED 2020 ALL-IRELAND JUVENILE SOFTBALL FINALS

The cream of Ireland's Juvenile Softball players converged on Thurles in late October to battle it out for the delayed 2020 MyClubShop.ie All-Ireland titles in the Softball code.

Cork topped the medal table with two titles, while Kilkenny, Roscommon and Sligo all taking one title back to their respective counties.

In the Boys U16 Singles Final Sligo's Cormac Finn was in sensational form against Kilkenny's Conor Holden in a high-quality match. Finn powered his way to take the first 15-1 as he controlled the game from start to finish with some excellent serving and killing shots, taking the title 15-1, 15-4.

The game of the day was the Girls U14 Singles Final with Cork's Carmel Kelleher against Kilkenny's Katie Brennan. After a long match, Kelleher held her nerve to hold off a spirited final push from Brennan, as the Kilkenny girl fought back from 14-10 in the tiebreak, before narrowly falling short 15-11, 7-15, 15-13.

Cork also claimed gold in the Boys U15 Singles as Hayden Supple defeated Kilkenny's Michael Brennan in two games 15-7, 15-13 whilst Kilkenny's Eimer Barron was an impressive winner of the Girls U15 Singles when she overcame Tipperary's Christine Percy 15-7, 15-4.

Finally, in the last game of the day Roscommon's Siobhan Treacy had a tight two game win over Kilkenny's Lauren Power on a 15-6, 15-10 score line.

### GOLDEN GLOVES, BELFAST

The 33rd edition of the Golden Gloves Tournament in Belfast saw a huge entry of 165 players across 14 grades, as Handballers came in their droves for the first large handball tournament since the Irish 4-Wall Nationals way back in February 2020.

A rare inclusion in this year's field was Cavan great Paul Brady, who at the age of 42 proved that age is merely a number, defeating all comers to win the Elite Men's title.

Brady still turned up in great shape, and of course his skill and execution levels being outstanding! Having seen off Jordan O'Neill, Colin Crehan and then narrowly edging Martin Mulkerrims in a super SF tiebreak en route to the Final, Brady then took down Charly Shanks 15-9, 15-0 in the final.

Catriona Casey justified her #1 seeding in the Elite Ladies grade with an excellent showing all weekend. After firstly defeating minor finalist Noelle Dowling, Casey saw off the spirited challenge of rising Armagh player Megan McCann over two fascinating games. The final saw her renew an old rivalry against hometown favourite Aisling Reilly. Casey blitzed the opener, but all of a sudden found herself 10-1 down in the second. One thing Casey is renowned for however is her battling qualities and she again showed that in abundance as she bit by bit reeled the home town player in to seal the win 15-13.



### DELAYED 2020 ALL-IRELAND ADULT 4-WALL FINALS

Twenty months on from their original scheduled date, GAA Handball finally got the chance to complete their 2020 All-Ireland 4-Wall Finals in November and December of 2021.

Due to Covid guidelines, the festival style weekend that has become the norm in recent years was not feasible, instead these outstanding finals were played across five different days in Kingscourt HC, Cavan.

The showpiece and eagerly awaited Senior Men's (Martin Mulkerrins v Robbie McCarthy) and Ladies Finals (Catriona Casey v Martina McMahon) unfortunately did not get played due to a mix of injury and unavailability reasons.

That meant the Minor Finals took top billing and they didn't disappoint. In the Ladies Minor, Tyrone's Mairead Fox's fast tempo style combined with her attacking power play saw her oust Noelle Dowling (Kilkenny) 21-11, 21-7. In doing so, Fox secured a rare treble of All-Ireland success' in the premier U14, U16 and U18 Singles grades, and became the first winner of the new Julie Long Cup, in memory of the former St Brigid's (Dublin) handball star.

Julie was a great ambassador for female Handball, winning numerous All-Ireland, European and US Nationals titles throughout an illustrious youth career. It was great to have this new Cup donated by her family and Dublin Handball to mark her contribution to the sport.

In the Men's Minor Final, the reigning champion Eoghan McGinnity (Monaghan) and Billy Drennan (Kilkenny) played out a thrilling three game Final, with McGinnity prevailing 21-3, 16-21, 21-13. In doing do he became the first player since Robbie Mc-Carthy in 2005 to retain the Minor 4-Wall Singles title.

In other Finals, Shane Dunne (Kilkenny) and Eilise McCrory (Tyrone) sealed their Senior status' by winning their respective Intermediate Finals. The full list of winners can be viewed in the 2021 Result Summary at the back of this booklet.

Kingscourt HC, Cavan, like so many times previous, deserve great credit for their hosting of these finals in difficult times. They provide a great venue that has aided GAA Handball's advancement so much, allowing so much more possibilities on event formats.

### DELAYED 2020 ALL-IRELAND JUVENILE 4-WALL FINALS

In the Juvenile Finals, Kilkenny swept the blue ribband U14 Singles grade as Katie Brennan and Conor Doyle both put in impressive performances against Roscommon's Shauna Corrigan and Cork's Diarmuid O'Connell respectively.

Cork did however respond to take the U14 Doubles sweep, as Carmel Kelleher & Leah O'Riordan prevailed, before Cian Dunning & Tomás O'Connor sealed a gripping tiebreak win over Kilkenny. A third Doubles title went Cork's way later in the day as Evan Enright & Cathal Ducey emerged the right side of a tiebreak to win the U17 Doubles crown.

Unfortunately an injury to Galway's

Mikey Kelly meant the Boys U16 Singles Finals did not take place, resulting in a walkover to the very exciting young talent that is Kyle Jordan of Kilkenny.

The Tyrone U16 Girls put in a great display to win both the Singles & Doubles Finals. Clodagh Munroe was very impressive in a dominant win over rising Galway player Emma Kinane, whilst Cloda Nic Con Midhe &

Aoibhinn Daly held their nerve against

a spirited Tipperary pairing to claim

the U16 Doubles title in two games.

The host county Cavan had plenty

to celebrate on Sunday as they took

home both the Boys U15 Doubles

(Niall Magee & Matthew Smith)

and Boys U16(Adam McKenna/Oli-

ver McCrystal) Doubles titles, which adds fuel to their continued growth at juvenile level.

Fresh from her delayed 2020 Softball title victory the previous month, Roscommon's Siobhan Treacy continued her upwards trajectory by adding the U17 Singles title on Saturday, coming back from a first game loss to defeat Una Brophy (Laois) in the game of the weekend!

### **STAFF CHANGES**

GAA Handball have underwent significant changes to their full-time staff team in 2021, with long time members John Kelly (National Manager) and Brigid Doheny (Administrator) having left the association in October and August respectively.

John Kelly held the position of National Fixtures Administrator for six years before becoming National Manager for the last seven years. Under testing financial circumstances there was notable progression under his tenure including;

- The introduction of the hugely successful All-Ireland 4-Wall Final Festival Weekend format.
- A strategic investment in live streaming of key events years before the trend has now become the norm across the sports industry.
- The development of a national award-winning website.
- The construction of the new National Handball Centre.

Brigid Doheny also served with GAA Handball for twelve years, having previously worked in the GAA for thirty two consecutive years. Brigid was an ever present at major Handball Finals during her time, and completed a huge amount of often unseen administration work.

Their commitment and effort was greatly appreciated, and GAA Handball would like to wish them the best in their future endeavours.

In January 2022, Offaly native Tom Moloney was appointed GAA Handball Interim Manager for a six month period. Tom was formerly GAA Operations Manager in Offaly and brings a wealth of commercial and GAA experience to his new role.

This is an exciting time for GAA Handball, with the pending opening of the new National Handball Centre and the recently launched Strategic Plan. Tom will play a key role in both projects, as well as undertaking a structural review of GAA Handball's operations over a six-month period.



### **FUNDING SUCCESS**

Just prior to the Christmas break, GAA Handball received a timely boost with the fantastic news on several funding streams which will be delivered upon in 2022.

A combined effort from GAA Handballs full time staff to produce detailed applications saw the below funding awarded to the association, totalling almost €150k.

### 1) Covid-19 Resilience Schemes - €100k

A reinvigoration of GAA Handball post pandemic. A wide-ranging programme targeting areas including: Volunteering, Coaching, Media/PRO, Tournament Grants & Facility Refurbishment.


### Dormant Accounts - Sport Inclusion - €40k

Developing Handball facilities and playing opportunities for disadvantaged areas via the 1-Wall code of the game, exposing Handball as a recreational activity for the masses.

### Dormant Accounts - IT Accessibility - €4k

To develop and adapt our re-





sources in line with a new inclusion strategy GAA Handball are currently undertaking with CARA (www.caracentre.ie).

### Special Projects - Online Coaching Resources - €5k

To develop online coaching content for the rapidly growing 1-Wall code of Handball, to the aid of the continuous stream of new Schools & GAA Clubs taking up the game.

### NATIONAL HANDBALL CENTRE

Whilst not operating at full capacity, it is pleasing to see Handball being played at the new National Handball Centre in Croke Park.

The HSE still occupy the building during day time hours, utilising the vast space as a Covid-19 Testing Centre. However, the Handball Courts are currently available at evening time throughout the week as part of a gradual opening. GAA Handball Staff are expected to move their full-time offices into the Centre in the coming weeks, with a full opening and launch to follow once final building works have been completed.

A new dawn for GAA Handball is near, with the state of the art new home being a focal point for the progression of our sport in the not too distant future.

### **YOUTH EXPO**

Finding ways to continuously interact with the GAA Handball membership base at the height of restrictions on indoor sport was tricky, but in April GAA Handball devised and hosted a hugely successful Juvenile Development Youth Expo.

The Youth Expo was a mammoth undertaking, led by Club Support Officer Pauric Dowdall, that saw daily online events take place every day throughout the month of April, including talks, workouts, cooking demonstrations and competitions. 'Tasty Tuesdays' provided an opportunity for young members to learn more about nutrition with Sport Ireland Nutritionist Sharon Madigan and her team. They shared several nutritional talks on what to eat before, during, and after games to help reach peak performance. There were also some cook-along videos showcasing how to make various foods that will help to fuel the body.

'Workout Wednesdays' seen top handballers put young members through their paces with World number one Killian Carroll doing a speed and agility workout while female star Catriona Casey hosted a very popular online skills workout. Tommy Gallagher, a sports injury specialist, dealt with preventing injury as players returned to the courts and he also delivered series of self-assessment tests to make sure members are in the best possible shape to avoid injury once they returned to action. Every Thursday, a range of top handball stars took over the GAA Handball Instagram account and shared their daily routines, coaching tips, and answer questions. We were delighted to have huge names from our sport take part; Catriona Casey (Cork),

The 'Friday Forum' seen international stars from 4-Wall and 1-Wall Daniel Cordova (USA) and Luke Thompson (England) join Ireland's Catriona Casey to talk about their Handball globetrotting exploits. Top handball stars Martin Mulkerrins, Martina Mc-Mahon and Diarmaid Nash discussed what it takes to succeed at the top while Galway's Ciana Ní Churraoin and Clare's Colin Crehan spoke about making the transition from underage to senior handball.

Finishing off the youth expo we had a keynote panel of speakers where All-Ireland winning Kerry footballer Kieran Donaghy, multiple All Ireland winning Cork dual star Rena Buckley and All Ireland winning hurler and former underage Handball star Richie Hogan (Kilkenny) discussed playing multiple sports and the benefits of same.

The Youth Expo proved to be a huge success and plans are afoot to hold another one over the coming months with the hope that it can take place in our new state of the art home in Croke Park. Note that all of these high-quality talks and interviews are permanently available to watch back on our official GAA Handball YouTube channel.

### **SUMMER SERIES**

In June we launched our Summer Series Initiative, a promotional and development campaign to help increase the visibility of Handball back in the public's eye, and for Handballers to have some fun and enjoy the game we had been deprived of for so long this past year. As a primary indoor sport, Handball can often go unnoticed to the general public, and unfortunately this was further emphasised during the pandemic. But it was so pleasing to see the Handball community roll in behind this campaign, bringing to life numerous outdoor facilities that had seen limited Handball action in recent years.

Ballyshannon's scenic outdoor 3-Wall court along the estuary was the host location for the official launch of the Summer Series 2021. Juvenile Coaching, a "Have a Go" session for beginners, and a sign up on the day local doubles tournament provided the entertainment as 20+ players aged from 20 to 70+ took to the courts for the first "Summer Series Club Tournament". A great turnout from the local Handball Club was treated to special guests from both GAA Handball and Donegal GAA. GAA Handball President Dessie Keegan was in attendance alongside Development Staff Darragh Daly and Pauric Dowdall, and was impressed by the facilities, the turnout and the growing appetite for recreational Handball.

Former Donegal All-Ireland winning All-Star Frank McGlynn, and current Donegal Senior star Paul Brennan both came along to show their support, and spoke positively of the benefits of Handball to the other GAA codes, and for GAA Clubs to take up the game on a recreational basis for their members.

Naomh Eanna HC (Antrim), Dungarvan HC (Waterford), St Brigid's HC (Dublin), Killyclogher HC and Carrickmore HC (Tyrone) are just some of the Handball Clubs who hosted very successful outdoor Summer Series tournaments that both reinvigorated their members and attracted new members.

Revamped courts at Edmund Rice College (Antrim), and community courts in Tullyvin and Crosserlough GAC (Cavan) also saw enjoyable events hosted, something that would not have happened in a typical handballing year.

It wasn't all about tournament play however, as Coaching Sessions and Taster Days were hosted in Dublin, Armagh, Westmeath, Antrim and Mayo to name but a few.

One of our newest and most progressive Clubs, Tourmakeady HC (Mayo), collaborated excellently with a local Heritage Group to host an evening of







Handball and History on the openair court in the village of The Neale, Mayo. Handball, Dancing, Story Telling and Music made for an actionpacked evening.

The 2021 edition of the Summer Series is only the start of GAA Handball's campaign to bring visibility of our sport back outdoors. I believe there is strong merit in making this a key annual development initiative having seen the positivity and awareness from this first instalment alone.

### NATIONAL COACH EDUCATION:

### **Coaching Courses:**

The past two years have been frustrating from a Coach Education perspective as the restrictions on indoor sport have severely limited our capacity to roll out a desired number of nationally led Coach Education Courses.

We did see a slight increase in the output of courses and participants from 2020, but these figures are significantly below post Covid levels. The area of Coach Education within our Clubs is something that I believe needs improved, providing more access and seeing an increase in the uptake of courses. With brighter days and fewer restrictions ahead of us, I hope 2022 is the year we can get back on track in this key area.

The roll out of Level 1 Coaching Courses by our team of National Coach Developers will be prioritised in 2022, targeting two per province for these two-day courses.

This year I also expect to see the roll out of a blended learning delivery method for our Coach Education Courses, with part of the courses being available online for participants to reduce travel and on court time requirements where possible.

### National Coach Developers:

Dublin's Meadhbh Ní Dhálaigh has almost finalised her training with Sport Ireland to become a National Coach Developer for GAA Handball. Meadhbh's pending qualification is a huge boost given the high standards and capability she has shown throughout the training process thus far. Not only will she play a key role in the future development of female coaches as part of GAA Handball's She's Ace programme, but her base of Dublin will also prove very beneficial in planned development programmes around the locality of the new National Handball Centre at Croke Park. Fergal Coughlan Sr (Clare) will finalise his qualification in 2022, whilst David Walsh (Cork) is the latest GAA Handball representative who has signed up to undertake the Sport Ireland led training in the University of Limerick. I am excited to see what both men can add to our team given their experience and thirst for knowledge.

There is a large range of resources already available, but Clubs are more than welcome to get in contact with suggestions that they feel would be beneficial to the growth of our game.



### NATIONAL HANDBALL ACADEMY

I expect and plan to see the resumption of the National Handball Academy in 2022 now that we have a programme of events to look forward to.

The programme was developed to provide an elite player pathway for juvenile players aged U14 - U18, aim-

ing to ensure our next generations of players are adequately supported to make the breakthrough into elite senior players, nationally & internationally.

The completion of the National Handball Centre, where GAA Handball can finally have a practical base, will allow us to expand the Academy opportunity into the Softball and 1-Wall codes and develop the next generation of talented players in these respective courts also.

### **SOCIAL MEDIA:**

Social media is a very powerful and important tool for development and promotion in a normal year, but last year our association saw its significance increase dramatically due to the pandemic restrictions.

### NOTES TO THE FINANCIAL STATEMENTS

### 1. GENERAL INFORMATION

These financial statements comprising the Statement of Income and Retained Earnings and the Balance Sheet and the related notes constitute the individual financial statements of Liathróid Láimhe CLG na hÉireann for the financial period from 1 November 2020 to 30 September 2021. The comparative period is the year ended 31 October 2020.

Liathróid Láimhe CLG na hÉireann is an unincorporated association. Liathróid Láimhe CLG na hÉireann is deemed to be a public benefit entity (PBE) in accordance with FRS 102.

#### Statement of compliance

The entity financial statements have been prepared on a going concern basis and in accordance with accounting standards issued by the UK Financial Reporting Council and the Companies Act 2014. The entity financial statements comply with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" (FRS 102).

#### Currency

The financial statements have been presented in Euro ( $\in$ ) which is also the functional currency of the Council.

### 2. BASIS OF PREPARATION

The financial statements have been prepared under the historical cost convention, except for certain assets and liabilities that are measured at fair values as explained in the accounting policies below.

The preparation of financial statements in conformity with FRS 102 requires the use of certain key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the financial year. It also requires the directors to exercise judgement in the process of applying the company's accounting policies. The directors believe there are no areas involving a higher degree of judgement or areas where assumptions and estimates have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

The exemptions contained within Section 1.12(b), 33.1(a) 33.7 of FRS 102 has been availed of in the preparation of these financial statements.

#### **Going concern**

Following the outbreak of the COVID-19 pandemic in March 2020, all handball activity ceased in line with Government guidelines. Due to handball being a predominantly indoor sport there has been limited activity since that date. Ongoing support is received from Cumann Lúthcleas Gael Central Council who have provided a letter of support to the organisation.

Liathróid Láimhe CLG. na hÉireann reported an operating surplus of €14,863 (2020: deficit €2,173) for the period ended 30 September 2021 and a net surplus of €114,863 (2020: €97,827). At the year end the accumulated deficit on reserves amounted to €893,773 (2020: €1,008,636). The financial statements have been prepared on the going concern basis which assumes Liathróid Láimhe CLG na hÉireann will continue in operational existence for the foreseeable future.

Given the uncertainties surrounding the duration of the pandemic, and the extent of disruption to sporting activities, Management acknowledge that the cash flow forecast is inherently uncertain in nature.

Management consider that it is appropriate for the financial statements to be prepared on the going concern basis as the measures taken to improve operating performance together with the on-going support of the Cumann Lúthcleas Gael will ensure the continued operational activity of the Liathróid Láimhe CLG na hÉireann for the foreseeable future.

### 3. ACCOUNTING POLICIES

The following accounting policies have been applied consistently in dealing with items which are considered material in relation to the financial statements.

#### Income

Grant income is recognised when performance related conditions are achieved. Other income is recognised on an accruals basis and recognised in the Statement of Income and Retained Earnings in line with underlying agreements.



### Property, plant and equipment

All property, plant and equipment are initially recorded at cost. This includes legal fees, stamp duty and other nonrefundable purchase taxes, and also any costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management, which can include the costs of site preparation, initial delivery and handling, installation and assembly, and testing of functionality.

Finance costs incurred during the construction period of property, plant and equipment that are directly attributable to the construction of those assets are capitalised as part of the cost of those assets.

Depreciation is provided on all property, plant and equipment, other than land, at rates calculated to write off the cost less estimated residual value, of each asset systematically over its expected useful life, on a straight line basis, as follows:

Office equipment	20% Straight line
Computer equipment	33% Straight line

#### Inventory

Inventories are stated at the lower of cost and net realisable value. Cost is based on normal levels of cost and activity and comprises cost of purchase and, where appropriate, cost of conversion to current condition and location.

Net realisable value comprises the actual or estimated selling price less all further costs to completion and all costs to be incurred in selling.

### **Financial Instruments**

#### Cash and cash equivalents

Cash consists of cash on hand and demand deposits. Cash equivalents consist of short term highly liquid investments that are readily convertible to known amounts of cash that are subject to an insignificant risk of change in value.

#### Other financial assets

Other financial assets including receivables, are initially measured at the undiscounted amount of cash receivable from that individual or entity, which is normally the invoice price, and are subsequently measured at amortised cost less impairment, where there is objective evidence of an impairment.

#### Other financial liabilities

Payables are measured at invoice price, unless payment is deferred beyond normal trading terms or is financed at a rate of interest that is not a market rate. In this case the arrangement constitutes a financing transaction, and the financial liability is measured at the present value of the future payments discounted at a market rate of interest for a similar debt instrument.

Management consider the accounting estimates and assumptions below to be its critical accounting estimates and judgements:
